Application for entry must be filled in and returned to the SNT with the documents set out in points 5 and 6 of the Notice of Race. Number of entries limited to 500 boats.

Skippers undertake to comply with the ISAF and FFV rules and regulations, the attached Notice of Race and the Sailing Instructions which will be issued on Thursday 13th April 2006.

Moreover, the skipper does not wish during the Spi Ouest France that abnormal commercial use to be made of the image of his boat or of the boat's name – particularly if the boat is racing under a business name - the skipper hereby requests OUEST-FRANCE and the SNT to take whatever steps are necessary to avoid such use being made. He hereby requests that the aforementioned take any action necessary in the event of such use being observed. Finally, the skipper and his sponsors, if any, under take not to make commercial use of the Spi Ouest-France throughout the duration of the event, nor on the race site, without first having obtained the organiser's prior consent. The skipper and his crew, the sponsor and boat's owner authorise the organisers to use, free of charge, any images which may be taken during the event.
